# 2. 150/21 DECLARATIONS OF INTEREST

There were no Declarations of Interest Declared.

#### 3. 151/21

# TO APPROVE THE MINUTES OF THE MEETING HELD ON THE19TH JULY, 2021

The Minutes were proposed as correct by Councillor Jean Davies and seconded by Councillor Colin Barker and formally agreed by the Members present.

# 4. 152/21 MATTERS ARISING

The Clerk referred to the following matters from previous Minutes:

- (1) **Minute no: 4. 133/21** (1) (page 2) in relation to vehicle activated signage in Pentre Halkyn. The Clerk advised, that following a complaint made, as requested in the July Council meeting, the following quotation and other information had been received.
- To supply and install two x VAS signs, to be sited in Pentre Halkyn, at a cost of £6,858.92 plus VAT £1,371.78 = Total £8,230.70. Subject to possible reduction, should the cost of solar power not be required, at £1,471.96 plus VAT).
- Five year maintenance payment of £119.00 for each year = Total £1,190.00

The Clerk recollected to Members, that the County Council had previously stared, that should this Council agree to the five year maintenance plan, then the County would place the units in their asset register for insurance purposes and also wave any call out fees, which are currently £56.00 per hour.

Members agreed the following: (1) The above two quotations (2) The siting of the two signs to be decided from the list of four possible locations, as previously identified following the traffic census (3) The Community Council thank the County for their assistance, together with inserting the units in the County asset register and call out aspect.

- (2) Minute no: 4. 133/21 (2) (page 2) in relation to 3 x bilingual Pentre Halkyn Village name signs. The Clerk advised, that Councillor Colin D'Arcy had been informed by Street Scene, that the signs were due to be installed in the very near future.
- (3) Minute no: 5(D) 137/21 (iii) (page 4) in relation to new signage in the Council owned Cemetery adjacent to St. Mary's Church, Halkyn. The Clerk advised, that following agreement to the bilingual wording by Councillor Bob Robinson, the Clerk had obtained a quotation from Palm Signs in Greenfield (This Company are on the County Council list of approved contractors). The Welsh wording for the sign had been provided by Mrs. Menna Coleclough. The quotation for £127.00 plus VAT £25.40 Total £152.40 (cost of new sign and installation and removal of existing sign); the quotation was forwarded to the Chair and Vice Chair of Council for consideration. The Clerk further advised, that the quotation had been agreed, whereby an official order had been sent to Palm Signs.

Members agreed the following: (1) Confirmed the acceptance of the above quotation (2) Thanked Mrs. Menna Coleclough for kindly translating the sign wording into Welsh.

- (4) Minute no: 5(D) 137/21 (iv) (page 5) in relation to the refurbishment of the bench seat in the Council owned Cemetery adjacent to St. Mary's Church, Halkyn. The Clerk advised that the seat had been refurbished and was back in situ. Members were shown virtually photographs of the seat
- (5) Minute no: 10. 144/21 (page 7) in relation to a Public Notice inviting local Groups and Committees within the Community Council area to apply for consideration to providing financial assistance towards events celebrating the Queen's Platinum Jubilee in 2022.

The Clerk advised, that interest has been received from Groups and Committees in Rhes Y Cae and Rhosesmor.

# 5(A). 153/21 CORRESPONDENCE

- (2) Independent Remuneration Panel for Wales: Annul Consultation in relation to Councillors expenses.

**Members agreed the following:** The Clerk to advise the Police of the following: Concerns raised by Councillors as to the potential implications of identifying residents in our area for the ongoing operation. These concerns included:

- Untrained personnel in safeguarding children or adults at risk
- Implications of identifying someone as vulnerable and the residents perceived understanding of this
- Implications of joint-working with North Wales Police and attending a residents home / community impact.

# 5(B). 154/21 CLERK'S REPORT

- (a) The Clerk advised Members in relation to the following deposit to the Council's bank account:
  - £16,666.67 Flintshire County Council: Second precept payment for financial year 2021 / 2022.
- (b) Annual Return to the Independent Remuneration Panel for Wales, in relation to published allowances and expenses for Members 2020 / 2021; the Clerk confirmed, that the annual report had been submitted to the Panel.
- (c) Annual return to the Charity Commission: The Clerk confirmed, that the return for Halkyn Parish Hall Registered Charity financial details had been provided to the Commission, for financial year 2020 / 2021.
- (d) Request for the Clerk to place political contact details on all the notice boards within the five villages. The Clerk advised members, that he had denied the request, in particular, as to why should this Council pay a travelling fee of 45p per mile, including the Clerk's working time to display this type of notice.
- (e) Application received from Nightingale House Hospice on behalf of a local family to plant a tree in memory of a relative, in either the children's play area or the grounds of the Village Hall. The Clerk had provided contact details for both areas.

- (f) The Clerk advised, in relation to a complaint from a number of walkers of a resident allegedly blocking a footpath in the Community Council area. The information together with plans were forwarded to the County Footpaths Officer for investigation.
- (g) The Clerk advised, that he had been made aware of an interment of ashes in the Council Cemetery, including the installation of a memorial stone, whereby both had not been authorised, including no fees paid. The Clerk visited the Cemetery and found the memorial stone in situ. Members were shown virtually a photograph of the stone. The Clerk had thereafter contacted the Funeral Director in Buckley. The required forms and fees have been received. The Clerk has written to both the Funeral Director and Memorial Stone Mason to express the Council's disappointment with the situation.
- (h) Complaint in relation to a large vehicle travelling in the Halkyn area at approximately 4.30am during the morning period. The Clerk advised, that he had written to the Office of the Traffic Commissioner, seeking if this vehicle has an HGV licence. To-date there had been no reply.
- (i) The Clerk advised, that following complaints received in relation to a mole infestation in the Council Cemetery adjacent to St. Mary's Church, Halkyn, the Clerk had contacted a pest control company. The fee of £185.00 was agreed in-between meetings by the Chair and Vice Chair of Council.

# Members agreed the following: Confirmed the fee of £185.00.

(j) The Clerk advised Members, that the Library Service held in the Halkyn Parish Hall had recommenced, whereby a risk assessment had been completed by Aura Leisure & Libraries. The Clerk further advised, that a Service Level Agreement until the 31<sup>st</sup> March, 2022 had been signed by the Clerk, as authorised by the Chair and Vice Chair of Council. This was a continuation of the previous agreement, whereby the cost of the service had been agreed in the budget setting process for this financial year.

**Members agreed the following:** Were pleased that the library service had re-commenced and confirmed the signing of the Service Level Agreement.

(k) The Clerk recollected Members to their previous decision to match-fund with Flintshire County Council (Aura Leisure) the sum of £10,000.00 towards new play equipment in the Halkyn children's play area. The Clerk further advised, that the application was successful, whereby new equipment together with installation costs will be in the region of £35,000.00. There will be no extra contribution required from this Council.

Members were shown virtually the costings together with photographs of suggested equipment.

**Members agreed the following:** Whilst the Members were pleased with the play items in the proposed draft equipment schedule, reservations were expressed in relation to the basketball item; would this be suitable for the area, given the uneven surface and interest to the younger generation. The Clerk to enquire if this item of equipment be replaced with something more suitable.

(l) The Clerk discussed with Members the Section 137 and other Local Government Acts, whereby this Council provide financial assistance to Groups and Committees who are registered within the Council area. This funding is provided to assist with the payment of

meeting room hire, general running coast and on occasions, towards capital payments. During the past financial year as recreational activities were curtailed due to the pandemic and subsequent government restrictions, there were only a limited number of applications received. The Clerk suggested to Members, that possibly a Public Notice could be circulated, whereby the Clerk had prepared a draft notice for consideration — which was viewed virtually.

Members agreed the following: (1) Confirmed the Public Notice and thanked the Clerk for his initiative (2) The Clerk to display the Public Notice on the Council web site, notice boards and forward a copy of the notice to Councillors, for uploading to the local village Facebook pages and both Clerk and Councillors to cascade to the various Groups and Committees within the Council area.

(m) The Clerk recollected Members to the Lottery grant of £950.00 to organise a Welsh Evening in Halkyn Parish Hall, whereby the utilisation date for the funding was August of this year; as the event could not be held the funding was transferred to the Halkyn children's play area refurbishment project. Councillor Wendy Sigsworth proposed that the original event to be held when restrictions allow in 2022. The Clerk further advised, that presently under the Parish Hall Risk Assessment a limited number of people are allowed to enter the building. The Wales Government restrictions also apply in relation to the wearing of facemasks. The Clerk suggested that the Council consider holding the event for St. David's Day in 2022.

**Members agreed the following:** To hold the event either on St. David's Day in 2022 or early this year.

- (n) The Clerk advised, that Councillor David Roberts had brought the following concerns to his attention:
  - (i) Dog walkers allowing their dogs to foul on the football pitch in Pentre Halkyn without clearing away. This area is currently the subject of a Community Asset Transfer to the Football Club. A junior match had to be called off recently due to the dog fouling. Councillor Roberts provided further information, including the provision of new signage.

The Clerk advised, all County Councils in Wales have a Control of Dogs Order - PSPO, whereby it is illegal to take your dog to designated children's play areas, football pitches etc., whilst the current order is being updated, the Clerk suggested that the concern is report directly by members of the Football Committee to the Dog Warden – using the Flintshire on-line forms.

(ii) Repair of wooden fences between the Football Club, children's play area and the County Council. Councillor Roberts enquired if the Community Council are involved in the discussions.

The Clerk advised, that the Community Council were consulted by the County Council almost two years ago, seeking if they would relinquish the lease of the football pitch, whereby the County wished to transfer to the Football Club. The Clerk further advised, that the Deed of Surender had been agreed and signed by this Council last year.

(iii) Concerns received by Councillor Roberts from horse riders in relation to two gates on Halkyn Mountain. The first gate at the top of the path running up the hill past the Church and are seeking if an extended opener can be fitted to be reached by those on horse back. Secondly, the gate (by the cattle grid) on the road that forks off this path, adjacent to the

lime kiln heading up the mountain; this gate does have an extended handle fitted, but apparently is not functioning correctly.

The Clerk advised, that he would have to consult initially with Rachael Watson the Halkyn Ranger, to ascertain as to whose responsibility are the gates.

**Members agreed the following:** The Clerk to contact Rachael Watson – Halkyn Ranger to ascertain responsibility for the gates and if in the remit of either Grosvenor Estate or Flintshire Countryside Services; to seek a new extended gate opener for the first gate and repair the second one.

(iv) Residents concerns in relation to the depositing of grass cuttings around the base of a tree which has been happening for a number of years and is an eye sore – the property is sited in the area of the notice board on the B5123 road in Rhosesmor. Councillor Roberts provided further information.

**Members agreed the following:** The Clerk to contact Street Scene to ascertain if the area is adopted highway and also seek advise, as to possible enforcement action to cease the above practice.

(o) Request from Councillor Nicola Richardson, that the Council seek the assistance of the Management Committee at Halkyn Parish Hall, to cut the hedge at the junction from the Bier House area and Halkyn Village Road; this will improve visibility for vehicles.

**Members agreed the following:** The Clerk to contact the Parish Hall Trustees and to seek that the hedge / branches are cut.

#### STREET LIGHTS

The Clerk advised, that a street lantern in the area of a property known as Nythfa, Halkyn had been reported faulty. Upon investigation it appeared that this particular light had not been changed from the orange SOX bulb to an LED bulb. This has now been completed.

#### 5(C). 155/21

# LOCAL GOVERNMENT AND ELECTIONS (WALES) ACT 2021: SECTION 47 (MULTI-LOCATION MEETINGS)

The Clerk recollected to Members that this subject had been discussed at a number of previous Council meetings and referred to an e-mail sent to Councillors dated the 4<sup>th</sup> August.

The present position is that meetings are unable to recommence at the Halkyn Parish Hall on a hybrid basis, as the Council are not in possession of the necessary equipment, including an internet access to the meeting room. Whilst the majority of Town & Community Councils in Wales are in similar circumstances, the Wales Government have issued the following statement: 'Further updates and guidance to Section 48 (47) Participation at Meetings of Community Council, will be issued in the autumn'

The Clerk further advised, that at the October Council meeting the Standing Orders will require amending to include the hybrid meetings aspect.

#### 5(D).156/21

#### TO CONSIDER: REPAIRS & OTHER WORK TO HALKYN PARISH HALL

The Clerk advised, that the following request had been received from the Management Committee of Halkyn Parish Hall:

- The paintwork is in need of renewing.
- The committee room window mullion needs repair.
- The guttering is leaking in some parts
- The roof space above the committee room and the toilets have no insulation. These areas are cold during the winter months.

Members agreed the following: (1) Were amicable to assisting financially with the above work; the installation and guttering aspects should possibly be addressed firstly. The Clerk to seek that the Parish Hall Trustees obtain quotations for consideration by this Council for the insultation and leaking guttering (2) The Clerk to enquire with the Parish Hall Management Committee, as to their plans for the grant funding received from the Welsh government.

#### 5(E). 157/21

# STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following matters that had been reported to StreetScene, since the last Council meeting:

- (1) Complaint in relation to overgrown tree branches on the B5123 in Rhosesmor almost opposite the Tiger Tim building. The Clerk recollected to Members that following a similar complaint some three years ago, it was established that the trees were the responsibility of Flintshire County Council Street Scene.
- (2) Complaint in relation to an overgrown hedge in the area of St. Mary's Church, Halkyn. Street Scene had advised the Clerk that the hedge was the responsibility of a local landowner. The hedge was cut the day following the complaint.

#### The Clerk advised, of the following update received from Street Scene (update in italics)

- (1) Red dog bin in Shone's Lane, Berth Ddu. This request was made a number of months ago, whereby the County had no bins in stock.
  - I will make contact with Cllr Bob Robinson for a location for a Dog Bin to be placed.
- (2) The following is a request from a resident. On the B5123 road travelling from Rhosesmor to Halkyn; can extra repeater 30mph signs be erected.
  - This section of carriageway was a recent speed reduction site and more than meets the currant signage criteria with repeater signs every 75m to 100m
- (3) The following is a request from a resident. On the B5123 road travelling from Rhosesmor to Halkyn; can signage be placed warning drivers of sheep in the area.
  - Following an inspection today (Monday 20<sup>th</sup> September) I can confirm that Sheep warning signs for 1 ½ miles are located oppose the Blue Bell Pub and 50m past the Rhosesmor Institute
