### Minutes of the Meeting of Halkyn Community Council, Held in the Halkyn Parish Hall, On Monday the 15<sup>th</sup> May, 2023, at 7.00pm

### **Community Award**

Prior to the commencement of the Council Meeting Councillors held a Presentation Ceremony to present to Mrs. Jean Roberts (Individual Award) and to Mr. David Wright (Committee / Group Award). These Community Awards were presented following public nominations received by the Community Council.

The retiring Chair of Council Councillor Colin D'Arcy in presenting Mrs. Jean Roberts with a Community Award, reflected on her service to the community for over 40 years and in particular, to the 35 years of both co-ordinating a voluntary car scheme for local residents and driving her personal vehicle to ensure that appointments were kept.

Councillor D'Arcy in presenting Mr. David Wright (who was accompanied by Members of the Halkyn Mountain News Team) with a Community Award, reflected on the almost 40 volunteers who cover the editorial, production and delivery of the quarterly editions of the Halkyn Mountain News to over 2,000 properties. The newspaper is a credit to the Community.

Framed Community Award Certificates together with bouquets of flowers were presented to Mrs. Jean Roberts and Mr. David Wright; Refreshments were provided.

### 8. 103/23 TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 17<sup>TH</sup> APRIL, 2023

The Minutes were proposed as correct by Councillor Glyn Coleclough and seconded by Councillor Wendy Sigsworth and formally agreed by the Members present.

### 9. 104/23 PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Minute no: 5. 73/23 (1) (page 2) in relation to speed monitoring tubes in Pentre Halkyn. The Clerk advised in County Councillor Simon Jones absence, that Councillor Jones has requested the speed survey, however, the information has not been received.
- (2) Minute no: 5. 73/23 (2) (page 2) in relation to correspondence to the North & Mid Wales Trunk Road Agency seeking a survey be carried out on the A5026 road to the A55 at The Nant. The Clerk advised that a reply had now been received from the above Agency. The Clerk read out the contents of the reply to Members, which referred to the following: Meeting held with the Welsh Government, North & Mid Wales Trunk Road Agency and owners of Hafod. Discussed concerns with horses / riders mixing with traffic on the slip road and parked HGV's. The accident record on the slip road does not record any incidents during the last five years; the Agency will continue to monitor the area.

- (3) Minute no: 5. 73/23 (3) (page 2) in relation to the white marker stones on Halkyn Mountain. Councillor Glyn Coleclough advised Members, that the Whitford Young Farmers will complete the painting of the white marker stones during the summer months.
- (4) Minute no: 6(A). 74/23 (3) (page 3) in relation to request for assistance form Ramblers Cymru. The Clerk advised that replies have been received from the following: Tarmac Quarries, County Minerals Officer and Rights of Way Officer. The correspondence confirmed that a site meeting had been held, whereby the County Council are considering a restoration plan and outstanding footpaths issues. The Clerk further advised that he had forwarded the various correspondence to Ramblers Cymru, who had replied and thanked the Community Council for their assistance.

The Clerk advised that a quotation had now been received to remove the existing vinyl inserts and replace with blue vinyl inserts, including a polish to the wood, at as cost of £360.00. The Clerk recollected Members to other requests for quotations that had been brought to their attention at the April meeting, including a more recent request from a Wirral Company, whereby non had been received.
