2(A). 143/23 PUBLIC QUESTIONS, COMMENTS OR REPRESENTATIONS

Standing Orders were suspended:

The Chair of Council Councillor David Roberts welcomed two residents to the meeting.

A resident of Pentre Halkyn addressed Council Members in relation to a pre planning application that had been in the public domain previously and in particular, to a proposed planning application for a Anaerobic Digestion Plant to be built at the former Ruby Brickworks in Rhydymwyn. The application area is on the edge of the Halkyn Community Council boundary with the Cilcain and Rhydymwyn Community Council. The resident advised they were a member of a local action group against the proposal.

The resident provided information as to the action groups objections and seeked that members of the Council attend a public meeting to be held in the Rhydymwyn Football Clubhouse on Wednesday 19th July at 7.30, whereby the planning applicant / agent will be in attendance. The resident was asked to provide the action groups objections in writing to the Clerk.

The Chair and Vice Chair Councillors' David Roberts and Howard Morris advised of their attendance at the public meeting in Rhydymwyn.

The Chair of Council Councillor David Roberts thanked the resident for attending the meeting and for the information provided.

TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 19TH JUNE, 2023

The Minutes were proposed as correct by Councillor Brian Coleclough and seconded by Councillor Colin D'Arcy and formally agreed by the Members present.

5. 147/23

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

(1) **Minute no:** 5. 128/23 (1) (page 2) – in relation to receiving results following a speed monitoring exercise on a number of roads in the Pentre Halkyn area. The Clerk recollected Members to the Excel spreadsheet that County Councillor Simon Jones had forwarded from the County Council which provided the results. The information was shown on screen and analysed.

Members agreed the following: Due to the 20mph speed reduction due for implementation in September of this year on roads with a current 30mph speed limit, the Community Council will consider a further review of traffic speed in the future, should the need arise.

(2) Minute no: 5. 128/23 (i) (page 2) – in relation to the Council's training plan and in particular to the attendance on a Mental Health training course by Councillor Nicola Richardson. The Clerk advised that suitable courses were held in Coleg Cambria, Northop named Highfield Level 2 Award in Introduction to First Aid for Mental Health (RQF). A two day course at a cost of £110.00.

Councillor Nicola Richardson advised that she wised to attend the course and would source suitable dates later in the year.

- (3) **Minute no: 5. 128/23 (ii (page 2)** in relation match funding for play equipment in the Rhosesmor Play area. The Clerk advised that Flintshire County Council (Aura Leisure) had confirmed, that this Council's share of the Rhosesmor play area match funding scheme would be £14,500.00, with the project in excess of £29,000.00.
- (4) Minute no: 6(B). 130/23 (b) (page 3) in relation to concerns with the number of water pipe leakages in the Halkyn Village area. The Clerk advised that following the sending of a letter together with a number of photographs to Welsh Water seeking the Water Board's plans for the future replacement of underground pipes in the Halkyn area to alleviate the water leakages.

The Clerk further advised that a lengthy reply had been received from Welsh Water, whereby a copy had been sent to Councillor David Palmer. Members were shown on screen the Water Board's reply, who advised that they were sorry for the number of leakages in the area, the asbestos cement pipe had been laid in 1970 from Rhosesmor to Halkyn. The water board are monitoring the area and fix leakages as soon as possible; teams are also working behind the scenes.

Members were shown on screen a photograph of a further recent water pipe leakage.

Members agreed the following: Councillor David Palmer to continue to monitor the situation.

- (5) Minute no: 6(B). 130/23 (b) (page 3) in relation to a request for a convex mirror on the B5123 Road in Halkyn with the Jubilee junction. The Clerk advised that the Count Council had replied to the request for a convex mirror and stated the following: The County cannot authorise the use of highway mirrors due to the 'flash backs' from vehicle headlights during darkness.
- (6) Minute no: 6(B). 130/23 (c) (page 4) in relation to the re-location of the projector and screen from the Parish Hall Committee room to the main Hall room, together with the purchase and installation of a new wall mounted television in the Committee room. The Clerk advised that following the June meeting he had written to the Chair of the Parish Hall Management Committee seeking their thoughts to the proposal. Whilst the request was acknowledged, there had been no further contact. Councillor Howard Morris advised that the proposal had been discussed in a recent Management meeting.

Member agreed the following: The Clerk to further contact the Chair of the Management Committee and to seek the decision of the Committee.

STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concern(s) that had been reported to StreetScene, since the last Council meeting:

• No matters of concern had been received and reported since the last Council meeting.

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer (*Update in italics*)

- ❖ B5123 Road in Halkyn: Conifer hedge opposite Central Stores obstructing public footpath. Will make contact with the farm
- ❖ B5123 Road in Halkyn: Tree branches require cutting back on Church Hill. *Have spoken with the Castles woodman a tree thinning programme is planned*
- ❖ Martins Hill, Pentre Halkyn: Laurel hedge requires cutting back. Will make contact with property owner
- Church Lane, Rhosesmor: Large pot hole (reported previously). Already listed for repair will be chased up

Members brought the following concerns to the meeting:

- (1) Top of Springfield Hill: White give way and other road markings could they be repainted
- (2) Church Lane, Rhosesmor: Pot hole repaired but tarmac is now lifting

The Clerk advised that the above concerns would be brought to the attention of StreetScene.
