## PUBLIC QUESTIONS, COMMENTS OR REPRESENTATIONS

- (1) Two reports of a burnt out vehicle on Halkyn Mountain Common, with one request seeking that Community Councillors tow the vehicle to the public highway where the Police will be able to take action. The Clerk had replied to advise, that this was not possible, as the Community Councillors could potentially commit both a criminal and road traffic offences.
- (2) Photographs provided by a concerned member of the public in relation to footpaths numbered 40 and 41 running from the Quarry to the area of the former Pen Y Henblas quarry. The area is being used by vehicles including off road bikers which has caused a muddy quagmire and almost impossible to walk along. (Photographs were shown on screen).

## PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Halkyn Parish Hall: The Clerk advised that the Land Registry had requested the following information to enable the change of name and postal address for the Halkyn Parish Hall to be completed (i) Identification form to be signed; the Member of the Welsh Government has been approached (ii) Certificate from Flintshire Street Numbering Department; an application has been made with a cost of £70.00 for the certificate.
- (2) **B5123 Road Overhanging tree branches:** The Clerk advised that a letter had been sent to the property owner (copy provided to Councillor David Palmer) seeking that the

overhanging branches are removed and also seeking a survey of the trees that overhang the highway. The Clerk advised that there had been no response.

**Members agreed the following:** Adjourn to the May meeting to await a reply.

(3) Halkyn Community Councillor – Vacant Seat: The Clerk advised that the Office of the County Returning Officer had stated the following: Should there be more than one candidate for the position an election will be held on Thursday 16<sup>th</sup> May. The Public Notice had been displayed on the Council's web site and Pentre Halkyn notice board.

(1) One Voice Wales: The Clerk advised that a request letter had been received to join One Voice Wales membership for year 2024 / 2025 a cost of £526.00, with a 50% discount for the first year at £263.00.

## Members agreed the following: Not to join.

(2) North & Mid Wales Association of Local Councils: Correspondence providing details of the work currently being dealt with by the Association, which includes the Railways, County Council future delivery of services and Welsh Government proposals to increase representation of the management of charities, together with local health services. Invitations to join the Association at a yearly current fee of £65.00, including an invitation to attend their next meeting to be held in the Civic Hall, Connah's Quay on Friday 19<sup>th</sup> April at 10.30am, with an optional lunch at £12.00.

## Members agreed the following: Not to join

(3) Scottish Power: Notification that from later this year to early 2025 Scottish Power will cease to provide a contract for un-metered street lighting supply.

**Members agreed the following:** The Clerk to make contact with other electricity suppliers and to seek quotations.

## The following correspondence was forwarded by e-mail to Members:

- ❖ Urdd Gobaith Cymru: Information in relation to the Urdd's Fund for all, which this year offers 300 free places at the Urdd summer camp for children and young people in Wales. Councillors were asked to forward to residents for information
- North Wales Fire & Rescue Authority: Public consultation on continuing to prevent and respond to emergencies. Councillors to complete on a personal basis

## 6(B). 76/24 CLERK'S REPORT

- (a) The Clerk recollected Members to a previous discussion in relation to placing white painted stones on grass verges across the mountain area. Councillor Wendy Sigsworth had received comments in relation to a number of areas whereby further white painted stones have recently appeared. The Clerk advised, that following previous enquiries, the Flintshire County Highways confirmed; as the areas where the white painted stones are sited is not highway adopted, and therefore, were not able to make comment. The Grosvenor Estate were approached and their view was: there was no concern but residents should be conscious of not placing stones too near the roadside.
- (b) A sign has been sited on a gate leading to a track from the cattle grid in Berth Ddu to Middle Lane and headed as follows: Police Notice and advises, that under the Police Reform Act 2002 vehicles may be issued with a maximum fine of £1,000.00 for using the public track / footpath. This is causing difficulty for two local farmers in particular, who use this track to gain access to a number of their fields. The County Footpath Officer has been asked to consider relocating the sign to another part of the track, which would allow access for the farmers. (Photograph of the sign shown on screen).
- (c) The Clerk advised that a new Service Level Agreement had been received from Aura Leisure to continue the Friday afternoon library service in Halkyn Parish Hall. The Clerk recollected Members to the budget setting process held in January of this year, whereby Council agreed to include the library recharge in the budget for 2024 / 2025. The Clerk further advised, that the recharge for year 2023 / 2024 was £3,776.16 and is included in the list of payment for consideration later in this meeting.

**Members agreed the following:** To continue with the Library Service at Halkyn Parish Hall. The Clerk to sign the Service Level Agreement on behalf of this Council.

## STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concern(s) that had been reported to StreetScene, since the last Council meeting:

## The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

No update in relation to previously reported concerns had been received from Street Scene.

## Members brought the following concerns to the meeting:

(i) Potentially dangerous cattle grid sited on the B5123 road in Berth Ddu – travelling towards Rhosesmor. The concern has been previously reported last year, however, the defects have increased with cracks and metal which appears to have broken and fallen off. The rattling aspect of the grid has increased tremendously when driven over by vehicles. (Photographs shown on screen).

The Clerk advised that due to the urgency, the above concern has been reported together with two photographs direct to Flintshire Customer Services. A reply received from Street Scene on the morning of this meeting advised, that the County are awaiting quotations for the repair to the grid

- (ii) Pot holes in a number of areas in Rhosesmor that were reported to County Councillor Simon Jones and forwarded to Street Scene. Could you please advise, as to when these pot holes will be repaired
- (iii) Berth Ddu Bus shelter: The metal gate requires urgent attention

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

## REPRESENTATIVES REPORTS (COMMITTEES, LIAISON & MEETINGS ATTENDED)

- (i) Hendre Tarmac Quarry Liaison Meeting: Councillor Dylan Roberts advised of his attendance at a recent liaison meeting held at the Hendre Quarry. Councillor Roberts provided the topics discussed which included the following:
- ❖ The tonnage currently being extracted form the quarry, including over the past four years
- ❖ Possible nineteen years of production time remaining at the quarry
- Dust concerns; the quarry do water spray vehicles
- ❖ Concerns with vehicles queuing on the A451 road awaiting entry into the quarry
- Substantial financial investment proposed, to include new administration offices and other work at the quarry

**Members agreed the following:** The Clerk to enquire with the Quarry Management, as to why the Halkyn Community Council are not formally advised in relation to the dates of the Quarry Liaison meetings.

## COUNTY COUNCILLORS REPORTS (COUNCILLORS' SIMON JONES & FRANCES LISTER)

## The Clerk provided the following information on behalf of County Councillor Simon Jones:

(1) At the request of Brynford Community Council Councillor Jones has seeked a meeting with the North Wales Police to address concerns with off-road biking in the area. Councillor Jones is extending the invitation to one of more Halkyn Councillors to attend this meeting, as this concern affects the Halkyn Council area.

The Clerk advised that the Police had replied to the Clerk to Brynford Council suggesting a meeting on either Thursday or Friday of this week.

Members agreed the following: The Clerk to advise both County Councillor Simon Jones and Clerk to Brynford Community Council that Councillors' Howard Morris and David Palmer wish to attend the site meeting with a North Wales Police representative. This Community Council also have consistent concerns with off-road vehicles causing annoyance to residents and damage in the area.

(2) Various road repairs within this Council area, the County have advised that the repairs will commence towards the end of May to early June.

## **County Councillor Frances Lister advised in relation to the following:**

- (i) As this was County Councillor Frances Lister's first attendance at a Community Council meeting, the Councillors held a general discussion in relation to the area.
- (ii) Discussion held in relation Police Consultative meetings that were previously facilitated by the local Police Inspector in Mold, and held between Town & Community Councils in the Mold Police district area.

**Members agreed the following:** Thanked Councillor Lister for offering to liaise with the North Wales Police to discuss the re-commencement of the Police Liaison meetings.
