## PUBLIC QUESTIONS, COMMENTS OR REPRESENTATIONS

## **Standing Orders were suspended:**

The Chair of Council welcomed Mr. Andy Dunbobbin (North Wales Police & Crime Commissioner) to the meeting.

Mr. Dunbobbin thanked the Council for hosting his visit and advised of his role and duties as a Police Commissioner. The role includes the appointment of a Chief Constable, budget setting (£six million in North Wales). The role involves the Commissioner sitting on cross-party groups and is non-political. Sets the police and crime objectives for their area through a police and crime plan.

Councillors discussed the following with the Commissioner:

- The lack of Police Consultative liaison meetings following the pandemic. The Commissioner will address this concern with the local Inspector. The meetings should be held at least every six months
- Concern with the high number of reported criminal offences that occur in the Halkyn Community Council area, including off-road bikers. The Commissioner was shown on screen the latest crime figures for the Council area. The Commissioner will arrange for the Rural Crime Team to provide the Council with a presentation
- Non-attendance at Council meetings by the appointed PCSO for the area. The Commissioner will arrange for attendance of a PCSO at Council meetings, at least every quarter
- Visits to schools. The funding for school liaison offers is ceasing. Arrangements can be made for Police representatives to attend schools and Governors meetings

Mr. Dunbobbin was thanked by the Chair and Council Members for his attendance and informative presentation.

## THE CLERK ADVISED IN RELATION TO THE FOLLOWING PUBLIC CONCERNS RECEIVED:

• (i) Concern received from local resident in relation to the condition of the cattle grid on the B5123 road in Berth Ddu, and in particular, the noise aspect and looseness of the metal railings. The resident had reported the concern to the County Council on a number of occasions, but had received no reply.

The Clerk had advised the resident that the concern had been raised by the Community Council with the County Council on more than one occasion, whereby the County had informed the Community Council that a repair quotation was being considered.

(ii) The resident also raised a complaint in relation to the refuge collection service and in particular, the removal and non-replacement of a bin. The Clerk had advised the resident that this concern was in the remit of the County Council and had copied County Councillor Simon Jones into the reply.

## TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 15<sup>TH</sup> APRIL, 2024

## PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Halkyn Parish Hall: The Clerk advised that unfortunately, no progress had been made. Whilst Flintshire County Council have still not issued the certificate in relation to the name and correct address, the Land Registry identify verification process is causing a difficulty. The process requires certain professions to certify a copy of their personal passport to be sent to the Land Registry, like wise for the Clerk. Hannah Blythyn MS is unable to provide her copy passport due to government security. Ms. Blythyn has written to the Land Registry seeking that this difficult process is reviewed.
- (2) **B5123 Road Overhanging tree branches:** The Clerk advised that there had still been no reply from the property owner, despite a copy of the letter sent in May.

**Members agreed the following:** The Clerk to send a copy of the letter to Street Scene, seeking that they endeavour to make contact with the property owner to alleviate the concern.

- (3) **Traffic Mirror adjacent to B5123 road in Halkyn:** The Clerk advised that there had been no reply from the Grosvenor Estate. The Clerk had sent a reminder.
- (4) **Public notice on bridleway in Berth Ddu:** The County Footpath Officer had advised the following: 'The Public Signs have been erected by the Access Team which prohibits illegal offroad access by motorbikes and 4 x 4 vehicles using this bridleway. A landowner who has a legitimate right of access to their property, such as land along the bridleway will not face a fine'
- (5) Community Award Timeline: The Clerk advised that a Public Notice will appear in the next edition of the Halkyn Mountain News in relation to the Community Award. Notices have been placed on all the Council's notice boards. The closing date for nominations is 12 noon on Monday 8<sup>th</sup> July, whereafter the nominations will be considered by Council on Monday 15<sup>th</sup> July.
- **(6) Hendre Tarmac Quarry Liaison Meetings:** The Clerk advised that he had made contact with the Hendre Quarry Manager, who has now placed the contact details for both

Councillors Howard Morris and Dylan Roberts on the list of attendees for the liaison meetings.

## 10(A). 104/24 CORRESPONDENCE

- (2) Groundworks North Wales: Funding for Communities. The information advised that funding was available for various projects which included primary schools in Flintshire. The Clerk had forwarded the correspondence to the Head teacher at Ysgol Rhos Helyg, Berth Ddu.
- (3) Flintshire County Council: Notification of uncontested election in the Pentre Halkyn Ward of Halkyn Community Council. Name of Candidate: Matthew Lister / Home address: The County of Flintshire / Description: Welsh Labour.
  - Councillor Brian Coleclough requested the Clerk seek the names of the ten residents who requested an election to be held. The Clerk advised that he would write to the Flintshire County Returning Officer.
- (4) Flintshire County Council Aura Leisure: Notification of annual match-funding scheme for improvements to children's play areas 2024 / 2025. The report identified the Halkyn Play Area as being in need of investment. The Clerk recollected Members that contained in the ear-marked reserves a sum of £10,000.00 towards the Rhosesmor play area with an emphasis on accessible equipment. The ear-marked reserves also contained £1,000.00 for picnic tables for the Rhosesmor play area. The Clerk advised that the match-funding monies cannot be utilised for play areas not identified for improvement.

Members agreed the following: (1) The Clerk to seek from the Play Officer details as to the requirement for upgrading the Halkyn play area (2) The Clerk to discuss with the Play Officer the provision of an accessible item of play in the Rhosesmor play area (3) The Clerk to obtain quotations for two picnic tables for the Rhosesmor play area.

(5) Request received from Ron Bailey on behalf of Lord Don Foster (House of Lords) seeking that this Council support a Bill to improve the safety of lithium batteries – as used in e-bike and e-scooters, including their disposal. The Bill is supported by a number of national organisations, including Electrical Safety First, National Fire Chiefs, Association of Ambulance Chief Executives, The Royal Society for the Prevention of Accidents and Royal Society for Public Health.

**Members agreed the following:** The Clerk to reply to Mr. Bailey to confirm this Council's support to a Bill to improve the safety of lithium batteries.

It is only right that I tender my resignation with immediate effect, to allow somebody with more time to give to the Council. I would like you to pass on my thanks to the other Councillors for their hard work and dedication, and of course to the Clerk for all his support'.

**Members agreed the following:** (1) Accepted the resignation of Ray Faulder-Jones and asked the Clerk to write and thank Mr. Faulder-Jones for his service as Councillor to this community (2) The above agenda item was withdrawn (3) The Clerk to notify the Returning Officer of the resignation.

## TO RECEIVE INTERNAL AUDIT REPORT: YEAR ENDED 31ST MARCH 2024

The Clerk recollected Members to a copy of the recently received Internal Audit report for year ending March 2024 - that had been sent to Councillors prior to the meeting.

The Council noted the following comments in the report: Conclusion - On the basis of the internal audit work carried out, which was limited to the tests indicated above, in our view the council's system of internal controls is in place, adequate for the purpose intended and effective.

The Council also noted the comment in relation to reserves. The Clerk advised that unfortunately, the internal auditor had not requested an updated copy of the actual ear-marked reserves breakdown for year 2024 / 2025, which identifies two items at £10,000.00 (Aura Leisure / FCC Match-funding) and an outstanding Work Order for £5,000.00 (Street Lighting inspections) that was over three years old. These aforementioned figures takes the Community Council's general reserves to well within the guidelines. Whilst the total were included in the budget setting process in January 2024, the Council will further update the ear-marked reserves during the quarterly reviews.

**Members agreed the following:** Accepted the Internal Audit report and thanked the Clerk for the financial aspect of his duties over the past year.

## Members brought the following concerns to the meeting:

- (1) B5123 Road with A541 junction in Rhydymwyn: Tree branches obstructing visibility on the Rhydymwyn side
- (2) Rhes Y Cae (unnamed road) From the top area of Rhys Y Cae to the former shop overhanging hedge at first house on left hand side causing difficulty for passing vehicles (Concern reported on more than one occasion to Street Scene by residents)
- (3) Berth Ddu: Pot holes on Shone's Lane
- (4) Berth Ddu: Graffiti still not removed from bus shelter as previously reported
- (5) Rhosesmor children's play area. Could a litter bin be installed please

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

TO DISCUSS: CONCERNS WITH EASTBOUND SLIP ROAD AT CASINO JUNCTION (CLLR BRIAN COLECLOUGH)

Councillor Brian Coleclough expressed his concerns to Councillors in relation to the A5026 Road - Casino Junction with A55 at The Nant.

This particular slip road is the scene of many accidents, which generally closes the road and causes inconvenience. In April for instance, there were two accidents on the 2<sup>nd</sup> and 16<sup>th</sup> – there are many other accidents that are not reported. The A55 Road is higher than the slip road which appears to be the main cause of concern – and ultimately reduces the visibility of drivers gaining access to the A55. The slip road is also of a short length.

Councillor Howard Morris advised, as a haulage contractor whilst driving a lorry on this slip road to gain access to the A55 the mirror visibility is of no concern, but when his family vehicle is used it is difficult to see in the mirrors the vehicles travelling towards him on the A55 prior to joining the road.

Councillor Coleclough advised, that he would be pleased to meet on site with Mr. Ken Skates MS (Cabinet Secretary for North Wales and Transport).

**Members agreed the following:** The Clerk to write to Mr. Ken Skates MS seeking a site meeting at this particular road junction. The invitation to be copied to: Hannah Blythyn MS & Police Inspector Iwan W. Jones (Flintshire South).
