TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 28TH APRIL, 2025

The Minutes were proposed as correct by Councillor David Roberts and seconded by Councillor Howard Morris and formally agreed by the Members present.

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Convex Mirror: To be placed in the pending file.
- (2) Footpaths on Halkyn Mountain: To be placed in the pending file.
- (3) Street Lighting Electricity Supply: The Clerk read out a letter that had been sent to Hannah Blythyn MS, which expressed this Council's concern that Mark Drakeford (Cabinet Secretary for Finance and Welsh Language) had not replied to the letter sent by Miss. Blythyn three months ago. Miss. Blythyn had replied to advise that a follow up letter had be sent to Mr. Drakeford.
- (4) Rhes Y Cae Play Area Upgrade: Members were shown on screen details received from the Gwella / Flintshire Play Design Officer to proposed new play equipment together with ancillary work, including a new entry gate in the Rhes Y Cae children's play area. The County clarified, that the match-funding for the additional play items and work in the play area totalled £10,000.00 with this Council funding of 50% at £5,000.00. The County had confirmed, that should the project overspend the County would provide the additional funding. Further discussion in relation to sheep gaining access from a gateway to the play area.

Members agreed the following: (1) Confirmed the allocation of £5,000.00 from ear-marked reserves to match-fund the project in Rhes Y Cae children's play area (2) The Clerk to further contact the Play Design Officer to advise, that the sheep are gaining entry from the gate that faces the football pitch. Could the mechanism be inspected and either repaired or replaced.

- (5) Joint Consultative Committee (JCB) Halkyn Mountain Common: The Clerk advised that the following reply had been received from Tom Woodall (Flintshire Access and Natural Environment Manager) 'I do feel that the discussions to re-establish the JCB have been going on for quite some time now and nothing has been resolved, so there is a risk that it will continue to drift. Subject to HSBC, I think unless there is a definite move to re-start things with a nominated Chair, Treasurer and Secretary by the end of the month, I will move to close the account'
- (6) **British Red Cross:** The Clerk advised that whilst he had written to the Course provider accepting the offer of free emergency first aid and defibrillator training and seeked that they are hosted in the Halkyn, Pentre Halyn, Rhosesmor and Rhes Y Cae Village Halls. As the

course provider is inundated with requests from across North Wales, it will be some time before any dates are able to be arranged.

(7) Community Award: The Clerk confirmed the following: The Community Award Public Notice has been displayed on all Council's notice boards in Halkyn, Pentre Halkyn, Rhosesmor and Rhes Y Cae, including the latest edition of the Halkyn Mountain News. The application form and policy document are available to peruse and download from the Council's web site, or by e-mail and hard copy from the Clerk.

The closing date for nominations is 12 Noon on Monday 14th July, whereafter Council will consider applications at the meeting to be held on Monday 21st July.

- (2) Flintshire County Council Legal Officer: Public Services Ombudsman for Wales. Recent case decision in relation to a Councillor's role as a trustee of a local community interest company. The Clerk provided Members with the contents of the letter
- (3) St Mary's Church, Halkyn. The Clerk read out to Members a letter received from Reverend Hugh Burgess in relation to an agreement for the shared water supply to the cemeteries at St Mary's Church and the Community Council cemetery adjacent to St Mary's Church. Prior to 2019 the water cost has been shared equally, unfortunately, due to the pandemic the Church had not requested payment. The Clerk advised in relation to each of the yearly charges that the Reverend had itemised.

Members agreed the following: Accepted the explanation for the non-issuing of invoices from 2019. The payment of £441.79 be included in the list of payments for authorisation during this evening's meeting.

The Clerk recollected Members that two signs in the Pentre Halkyn area were in the ownership of this Council and were included in the funding received from the Welsh Government to complete the changes. The work will commence in July over a period of months.

STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concern(s) that had been reported to StreetScene, since the last Council meeting:

• No matters of concern had been received and reported since the last Council meeting.

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

No update in relation to previously reported concerns had been received from Street Scene.

Members brought the following concerns to the meeting:

- (1) Middle Mill Lane: Continual deterioration of road surface Bluebell end of the lane
- (2) Area of road just past Cefn Road, The Nant (Known locally as Haunch). The road edge is badly deteriorated and falling away by many inches. Could the area be inspected as a matter of urgency, as should a vehicle tyres enter this area damage to the vehicle will occur

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

- Other concerns included in the Street Scene list:
- (a) Missed recycling collections: County Councillor Simon Jones to take forward with County Street Scene
- **(b)** Vehicle parking on the slip road between Bryntirion Road and the A55: Community Councillor requested to provide vehicle make, model and registration number to the Clerk who will thereafter report to the North Wales Police
- (c) Request for yellow parking enforcement lines in The Nant: County Councillor Simon Jones to take forward with County Highways

REPRESENTATIVES REPORTS (COMMITTEES, LIAISON & MEETINGS ATTENDED)

There were no reports specific to the Local Committees and Outside Bodies schedule, or Council Members who had attended meetings on behalf of the Council.

COUNTY COUNCILLORS REPORTS (COUNCILLORS' SIMON JONES & FRANCES LISTER)

County Councillor Simon Jones advised in relation to the following:

- (1) The recent change to the re-cycling programme had gone well, in particular, with the larger vehicles but has caused some difficulty with the smaller vehicles
- (2) Since the change of re-cycling programme there has been a 20% reduction in black bin waste

- (3) The 20mph speed limit in Rhes Y Cae is fully implemented
- (4) Community Speed Watch held recently in Rhosesmor resulted in capturing 35 vehicles travelling in excess of the 20mph limit; with 28 travelling over the 30mph speed limit from a total of 48 vehicles. The area of the speed watch covered the B5123 including the Rhosesmor children's play area
- (5) Street Scene continue to repair road defects, in particular, pot holes, whereby Councillor Simon Jones is in regular contact with the Street Scene Officer discussing the outstanding repairs
- (6) A number of scenarios reported during the meeting whereby the black bins were not collected. Councillor Jones advised as to the procedure to report missed collections of any type of bins
