The Chair of Council Councillor Delyth Taylor welcomed to the meeting the Community Award recipients for 2025 – namely, Menna Colclough and from the Rhosesmor Tots - Alison Leonard and Sharon Broughton.

Menna Coleclough: You have been awarded the individual award and your nominations form stated: 'That you had been a Committee Member of the Rhes Y Cae and Moel Y Crio Sheepdog Trials and Horse Show for many, many years. Through the Halkyn Mountain News you have kept the community informed about the show, the advertising, recording results – the list is endless. (1) Additional Step – Halkyn Parish Hall: The Clerk advised that a quotation had been received from G D Owen (Building Maintenance & Groundworks) for an additional concrete step, grab rail and hand rail from wall to floor at the side entrance to Halkyn Parish Hall, at a cost of £445.00. The quotation has been agreed by the Chair and Immediate Past Chair of Council.

Members agreed the following: Confirmed the above quotation.

- (2) Request for Yellow Parking Restrictions: The Clerk advised that County Councillor Simon Jones had requested Highways carry our a survey to ascertain if the area in The Nant reached the criteria for yellow lines. The County have a lengthy list of areas to survey and this request will be placed on file at the present time.

TO REVIEW (1) CEMETERY REGULATIONS (2) CEMETERY FEES FOR 2025 / 2026 (ADJ FROM JULY MEETING)

The Clerk provided Members with the current Halkyn Cemetery fees, with comparisons made between three other Cemetery Authorities in Flintshire.

Members discussed an increase between 10% and 15% - for both resident and non-residents, whereafter one proposal was made together with a counter proposal.

Members agreed the following, by majority: To increase the Cemetery fees for 2025 / 2026, as follows: (1) Resident no increase (2) Non-resident 15% increase - to be rounded up to the nearest £5.00.

STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concern that had been reported to StreetScene, since the last Council meeting:

❖ Invasive plant known as Himalayan balsam is growing on the roadside in the following area: Near to the Nant Chapel, The Nant.

COUNTY COUNCILLORS REPORTS (COUNCILLORS' SIMON JONES & FRANCES LISTER)

County Councillor Simon Jones advised in relation to the following:

- (a) During the summer recess complaints had been received in relation to non-collection of bins and recycling which generally relates to the same properties. Councillor Jones together with Councillor Fran Lister have arranged a meeting with County Officers to alleviate the concern. It appears that the larger vehicles are successful with their collections, whereby the smaller vehicles are the cause of concern
- **(b)** The off-road vehicles appear to have subsided across the mountain, which is due to the Police actions and Grosvenor Estate.
- (c) Discussion in relation to electric bikes
- (d) Councillor Brian Colectough expressed his concerns with the high number of accidents that are occurring on the A55 in the area of The Nant and Pentre Halkyn, in general. A number of the accidents have resulted in the attendance of the emergency services, including the air ambulance. Media reports state, that there have been serious injuries. The accidents block the A55 road with traffic being both gridlocked in the immediate area and other traffic travelling around the lanes endeavouring to seek a detour

Councillor Coleclough wished the Community Council to invite Ken Skates MS the Welsh Government Cabinet Secretary for Transport and North Wales to a site meeting.

The above item to be included in the October agenda.

County Councillor Simon Jones advised that he would write to Ken Skates with an invitation to attend a site meeting.

9(A). 176/25 PLANNING APPLICATIONS

The following planning applications had been received:

(a) Application number: FUL/000569/25 - proposed two storey extension including balcony, at Keepers Cottage, Groes Farm, Pant y Goff, Halkyn.

Comment by Council: No objection to the application, as long as planning policies and planning guidance notes are complied with.

(b) Application number: FUL/000606/25 – for proposed extension and remodel of property from sides, at Hill Cottage, Moel y Crio.

Comment by Council: No objection to the application, as long as planning policies and planning guidance notes are complied with.

(c) Application number: FUL/000642/25 – for proposed additional car parking, at Springfield Hotel & Country Club, Pentre Halkyn.

Comment by Council: Whilst there is no objection to the application, in principle * - as long as planning policies and planning guidance notes are complied with. however, the Community Care

concerned, that the monkey puzzle tree (araucaria araucana) is not referenced either within the application form and design & access statement.

The application form is ticked to confirm, that there are no trees or hedges on land adjacent to the proposed development site that could influence the development or might be important as part of the local landscape character. The monkey puzzle tree (araucaria araucana) is adjacent to the proposed development and sited within the current vehicle parking area for the hotel; the tree is an important part of the local landscape. Should this local landmark tree not be retained, then the Community Council * object to the planning application.

Note: Following reply received from Planning Officer: I have sought clarification on the matter raised from the agent, who has responded accordingly (italics): *I can confirm that tree is a cherished part of the site at the hotel and will remain as it is.*

(The above three applications were sent to members for consultation in-between meetings, due to statutory time limits for observations from County Planning).

(b) Application number: FUL/000738/25 – proposed general refurbishment and repair works of a dilapidated rural cottage to include the demolition of an existing single-storey conservatory and the construction of a new two-storey extension, of a similar footprint. Other minor alterations include removal of existing porch, window replacements and additional openings, to be undertaken under permitted development rights where applicable, at Pen Draw, Pentre Road, Pentre Halkyn.

Comment by Council: No objection to the application, as long as planning policies and planning guidance notes are complied with.
