TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 20TH APRIL, 2026

The Minutes were proposed as correct by Councillor Nicola Richardson and seconded by Councillor Matt Lister and formally agreed by the Members present.

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) **Street Lighting Electricity Supply:** The Clerk recollects Members to the correspondence sent to both Scottish Power and OFGEM expressing this Council's concern with the excessive increase to the street lighting monthly energy supply cost. Both identities replied advising that the way consumption is now recorded provides a more accurate reading – hence the higher kilowatt usage.

The Clerk further advised that the Clerk to Treuddyn Community Council is in the process of endeavouring to join the Government Procurement Contract for street lighting supply and has completed the first stage. The Treuddyn Clerk will advise a number of Flintshire Councils, including this Council when their application has been successful, whereafter, this Council can then proceed to join the contract. However, the process can take up to six months to progress.

- (2) **Additional Bench Seats and Community Garden in Rhes Y Cae:** The Clerk advised that there had been no further contact from the resident who was to enquire with the Rhes Y Cae Village Hall Committee, to seek their views on a Community Garden adjacent to the Hall
- (2) Councillor Nicola Richardson advised that the bench seating is still on progress.

- (3) **Halkyn Parish Hall – Vesting Order:** The Clerk advised that the Council's appointed legal representative, for personal reasons, was now not able to proceed with the Vesting Order. Another legal firm has been approached seeking a quotation.

- (4) **Halkyn Parish Hall Insurance:** The Clerk advised that he had sought a quotation to include the Halkyn Parish Hall on the Council's insurance policy. The cost quoted was £1,868.00, whereas the current insurance cost arranged directly by the Parish Hall Management Committee is £1,309.00 – an increase of £559.00.

Members agreed the following: The Clerk to advise the Parish Hall Management Committee.

STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concern that had been reported to StreetScene, since the last Council meeting:

- Dog fouling in the Halkyn area

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

- Dog fouling in the Halkyn area (*Street cleaning dispatched to area*)

Further update received from Neil Hickie (Street Scene) (*update in italics*)

- (1) B5123 Road in Bryn Alun area: 2 x grids blocked. *Request passed to delivery service for attendance*
- (2) B5123 Road in Bryn Alun area: Some pot holes have been repaired, with others still outstanding. *Listed for pothole repair and future resurfacing*
- (3) Pot holes and damaged road which requires upgrading: Middle Mill Lane, Pant Y Gof (This was reported in March – could an update be received). *Listed for pothole repair and added to resurfacing list for consideration*
- (4) Rhosesmor to the Green area in Northop: Pot holes. *Listed for pothole repair*
- (5) Halkyn to Rhes Y Cae Road: Some pot holes have been repaired, with others still outstanding – from the bridge area (This was reported in March – could an update be received). *Listed for repair and imminent return of “Pothole Pro”*
- (6) Bryn Tirion Road – at Lleprog Lane. The verge has partly collapsed following a lorry tipping over. The area was filled with soil which has compacted. The area is difficult to manoeuvre when two cars are passing without one vehicle going into the dip. Could this be investigated please. (Is the area within the Halkyn Street Scene remit). *In Area 2 (Bagillt) and will pass to Tom Cartright who covers that patch*
- (7) Bryn Tirion Road: Tremendous amount of litter. Can a litter pick please be organised (Is the area within the Halkyn Street Scene remit) *Cleansers Made a start on Tuesday 21/04/26 under contractor’s traffic management but unable to complete due to ongoing and dangerous traffic movement, will return on Friday 24/04/26 when physical road closure is in place*

Members brought the following concern(s) to the meeting:

- (1) Condition of roadway at junctions of B5123 and A5026. Could the area be inspected as the roadway requires a major repair or retarmacking. It is possible the condition of the road has deteriorated due to the heavy vehicles that use the area
- (2) Pot holes in the following areas:
 - (i) Moel Y Crio. From area of bus stop to Y Fferm
 - (ii) Moel Y Crio to Rhes Y Cae Road – travelling down hill
 - (iii) Halkyn to Rhes Y Cae road
 - (iv) Top of Martins Hill – between Buxton Lane and Rhes Y Cae junction
 - (v) Cross roads under A55 – travelling downhill from Springfield Hotel
- (3) The County Council are replacing the Vehicle Activated Speed (VAS) signage. The two VAS signage in Pentre Halkyn and one VAS sign in Berth Ddu have not been changed. The Clerk advised he would enquire with County Highways

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

- (ii) The Community Council are aware that both County Councillors for the Ward area – Fran Lister and Simon Jones have indicated their attendance at a full Planning Committee, including a member of a Resident Group who will also advise the Planning Committee, as to concerns with the application, on behalf of a number of residents. The Community Council feel that there is sufficient representation to speak in relation to the application, therefore, the Community Council will not be represented at the hearing.
- (b) Application number: FUL/000368/26 – for proposal to convert vacant barn to residential dwelling, at Pantauhirion, Rhosesmor.

Comment by Council: No objection to the application, as long as planning policies and planning guidance notes are complied with.
